NOTIFICATION

No. F.9/18/90-LSG/376 dated 25.01.21991.— The following recruitment and promotion regulations made by the Municipal Corporation of Delhi under 98 of the Delhi Municipal Corporation Act, 1957(66 of 1957) vide their Decision No. 930/GW/Corp. dated the 14.10.90 in connection with the recruitment for the posts of Director (Community Services) and Deputy Director(Community Services), Municipal Corporation of Delhi, having been approved by the Lt. Governor of the National Capital Territory of Delhi in pursuance of the provisions of subsection (2) of section 480 of the said Act read with the Government of India, Ministry of Home Affairs, Notification No. 3/6/66 Delhi dated the 19th October, 1966, are hereby published as under:-

1. Short title the commencement.-

- (i) These Regulations may be called the Recruitment Regulations for the posts of Director(Community Services) and Deputy Director(Community Services), Municipal Corporation of Delhi,1991.
- (ii). They shall come into force on the date of their publication in the Official Gazette.
- Number of posts, classification and scale of pay.

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the schedule annexed to these regulations.

Method of recruitment, age-limit qualifications etc.-

The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns 5 to 14 of the schedule I & II aforesaid.

- Disqualification.-No person-
 - a) Who has entered into or contracted a marriage with a person having a spouse living;
 or
 - b) Who, having a spouse living, has entered into or contracted marriage with any person shall be eligible for appointment to the said post provided that the Municipal Corporation of Delhi, may, if satisfied that such marriage is permissible under the

Corporation of Delhi, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this regulations.

5. Power to relax: - Where the Municipal Corporation of Delhi is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these regulations with respect to any class or category of persons.

6. <u>Saving</u>: Nothing in these regulations shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons, in accordance with the orders issued by the Municipal Corporation of Delhi time to time, in this regard.
