The contractors shall submit an undertaking that the firm has not been blacklisted/Debarred /Banned/Restrained anywhere in India by any Government department/Government Undertaking. The registered contractors of MCD (SDMC/NSDM/EDMC) are also eligible to tender, subject to technically qualified as per tender document, for the amount they have registered in their respective category subject to the conditions that they are neither black-listed nor debarred/banned / restrained at the time of purchase of tenders. 3. The Tenderer/Bidder should have valid Income Tax PAN No. & CGST/GST Registration.

4. SELECTION PROCESS A single stage, two-bid system/ process (Technical & Financial Bid) will be followed for selection of a suitable contractors for award of Rate Contracts. All interested firms that qualify each of the eligibility criteria may apply. Based on the Technical compliance of each proposal as submitted by the bidder, SDMC shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The department will have the right to arrive at reasonable eligibility L-1 price and may counter offer to higher quoting eligible firms for awarding Rate Contract. Rate Contracts may be awarded to maximum five Lowest quoting firms only when several/all the items on the counter offer are accepted by the bidders instead of acceptance in parts. The firms for Award of Rate Contract will be considered for award of works for a period of 12 Months. The Rate contract period may be extended, if required by SDMC.

Date for submission of manual Technical Bids 13.01.2021 till 1500 hrs. However the copy of documents submitted online for technical bids must also be submitted in the office of Dy. Director upto 13.01.2021 upto 03.00 P.M. The Technical Bids shall be opened on the same day at 1530 Hrs. <u>FINANCIAL BID</u> The Financial bids be submitted online at SDMC e-tenders portal website http://engineering.mcdetenders.com/common After evaluation of Technical bids by Evaluation Committee constituted by SDMC the financial bid of only technically qualifying firms shall be opened thereof and date of opening of financial bids shall be informed to the technically qualified bidders through mail or uploading its notice on SDMC website. <u>No manual submission of Financial bids of tenders will be accepted for any reason whatsoever</u>.

6. EXPERIENCE: Experience of having successfully completed works during the last 7 years ending previous day of last date of submission of application. Three similar completed works costing not less than the amount equal to Rs. 12.00 Lacs. OR Two similar completed works costing not less than the amount equal to Rs.18.00 Lacs. OR One similar completed work of aggregate cost not less than the amount equal to Rs.24.00 Lacs. (Completed Similar work means the work of Supply / Fixing Providing of plants)

OR Bidder may be a Registered Nursery Owner. The bidder will have to submit valid documents of established nursery, issued from Government Organization. Nursery owner should be dealing with Nursery business not less than one year.

OR Bidder may be a loint Venture of Plant Supplier & Nursery Owner. The plant supplier has to submit secondard under the plant Supplier to the

OR Bidder may be a Joint Venture of Plant Supplier & Nursery Owner. The plant supplier has to submit completed work/supply of plants supplied in any Government Organization. The bidder will have to submit valid documents of established nursery, issued from Government Organization and Nursery owner should be dealing with Nursery business not less than one year.

MANDATORY FINANCIAL TURNOVER Average annual financial turnover of the participants/Contractors/Bidders during the immediate last three consecutive financial years should be not less than the amount equal to 15.00Lacs. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three (3) financial years, should be submitted.

 PERFORMANCE SECURITY The successful L-1 contractor / bidder shall submit Performance security equal to an amount of 3% (Three Percent) of the Rate Contract amount in the form of Bank Draft / Pay Order / Bank Guarantee / FDR in favour of Commissioner, SDMC payable at New Delhi. The said performance security shall be deposited within 15 days of issue of Letter of Intent /Acceptance from SDMC.

(ix) If bidder is a nursery owner-documents of Nursery Ownership / Registration, issued from Government Organization. Nursery owner should be dealing with Nursery business not less than one year and should have at least one completed work of plant supply in any government organization. (x) If the bidder is a J.V. of Plant Supplier & Nursery Owner. The plant supplier has to submit completed work/supply of plants supplied in any Government Organization. The bidder will have to submit valid documents of established nursery, issued from Government Organization and Nursery owner should be dealing with Nursery business not less than one year along-with requirement as per vii & viii. SOLVENCY CERTIFICATE: Bidders will submit Solvency certificate for an amount equal to Rs.12.00 Lacs from a

Nationalised/Scheduled bank in India.

Based on the Technical compliance of each proposal as submitted by the Applicant, Financial bids of only eligible bidders shall be considered for opening. The Financial bids of qualified bidders will be opened by SDMC online at e-portal of tenders.
