#### **CIRCULAR**

Sub: Extension of Amnesty Scheme of "Waiving off property tax" in unauthorized regularised colonies.

With reference to the Circular dated 28.01.2021 and subsequent clarification issued vide Circular dated 16.02.2021 on the above mentioned subject, it has been decided to continue the Amnesty Scheme of "Waiving off property tax prior to 2019-20" on payment of property tax for the last two years i.e. 2019-20 & 2020-21 without any interest or penalty in r/o residential and non residential properties in unauthorised regularised colonies falling within the jurisdiction of South DMC till 31.03.2021 with immediate effect.

The terms and conditions of the scheme will remain the same as already issued vide Circular No. D-2051 dated 14.03.2020 and 4.9.2020.

Accordingly, all the Jt. A&Cs are advised to instruct the officers / officials working under their control to ensure strict adherence and to provide necessary assistance / guidance to the tax payers, as and when required. Special camps may also be organized in the area with the help of area Councillors to give the benefit of the scheme to maximum number of taxpayers.

The guidelines / norms issued by MHA / DoPT in view of COVID 19 should be adhered to while dealing with in general public.

All zonal Joints are also requested to inform the area Councillors under their jurisdiction about the scheme and seek their cooperation and help to bring as maximum as possible taxpayers into the tax net.
