Therefore, it is hereby agreed by and between the parties as follow:-

1. The supplier shall issue DSC Class-III signature with token at a cost of Rs.1400/- (inclusive of taxes) and for DSC Class-III Signature and Encryption with token at a cost of Rs. 2000/- (inclusive of taxes) in various department of SDMC.
2. The empanelment of the supplier shall be valid for the period of three years.
3. The supplier shall adhere to all provisions of the IT Rules as amended from time to time and issue certificate as per the standard specifications.
4. The DSC to be issued shall have a validity of 02 (Two) years from the date of issue of the certificate.
5. During the validity and support period, all software up gradation, bugs, patches and services shall be provided free of cost by the supplier.
6. The supplier shall provide support through telephone, e-mail, as sought by the user department of SDMC and shall also provide escalation matrix for handling technical issues, as amended from time to time.
7. The supplier shall provide the DSC to all departments in SDMC as per their requirement. DSC shall be supplied within 48 hours from communication of the requirements. In case of delay, a penalty of Rs. 100/- per day will be deducted from payment due.
8. Invoice for the DSC supply shall be raised directly on the user department and concerned departments shall make the payment directly to the supplier as per approved rates.
