Municipal Corporation of Delhi (MCD) invites Expression of Interest (EOI) for Empanelment of Kabariwalas for segregation of Solid Waste at Sanitary Landfill Okhla, Ghazipur & Bhalswa, who are authorized / empanelled by Central Pollution Control Board (CPCB) / Delhi Pollution Control Committee (DPCC).

At present, around 2000 to 2500 MTD fresh waste reaches at landfill site Okhla & Bhalswa each and around 2000 MTD fresh waste at Ghazipur. Usable material like plastic waste, steel, glass etc shall be segregated and transported out of landfill sites by empanelled agencies. All expenditure incurred for segregation of solid waste and its transportation shall be borne by empanelled agencies and not by MCD. Sub:- Expression of Interest (EOI) for Empanelment of Kabariwalas for segregation of Solid Waste at Sanitary Landfill Okhla, Ghazipur & Bhalswa, who are authorized / empanelled by Central Pollution Control Board (CPCB) / Delhi Pollution Control Committee (DPCC).

At present, around 2000 to 2500 MTD fresh waste reaches at landfill site Okhla & Bhalswa each and around 2000 MTD fresh waste at Ghazipur. Usable material like plastic waste, steel, glass etc shall be segregated and transported out of landfill sites by empanelled agencies. All expenditure incurred for segregation of solid waste and its transportation shall be borne by empanelled agencies and not by MCD.

Brief scope of work and terms & conditions for agencies shall be as under:-

- 1. A system of waste pickers for segregation of waste shall be established by empanelled agencies. 2.
- No minor workforce of waste pickers / rag pickers shall be deployed by agencies for segregation of solid waste or allied works.
- 3. Usable material recovered from solid waste through segregation shall be weighed in registered vehicles (covered) of agencies at weighbridge installed at every SLF sites by MCD at no cost. 4.
- Empanelled agencies shall ensure that no hindrance in the disposal work shall be created by waste pickers / rag pickers. 5.
- Segregated waste will be sold to approved recycling industries. 6.
- Empanelled Agencies shall also be required to submit certificates on monthly basis from approved recyclers / plant where the segregated waste is disposed off. 7.
- Empanelled agencies shall provide identity cards to waste pickers / rag pickers. 8.
- All protective kits as per norms shall be provided to the waste pickers / rag pickers. 9.
- Empanelled agencies shall provide medical facilities to waste pickers / rag pickers. 10.
- Empanelled agencies shall provide covered sheds to waste pickers / rag pickers in 11.
- Empanelled agencies shall provide all necessary training to waste pickers / rag pickers for segregation of valuable material from solid waste. 12.
- Empanelled agencies shall ensure that the waste pickers / rag pickers are covered under requisite Life Insurance Policy and Personal Accident Insurance Policy. 13.
- Any accidents occurred with waste pickers / rag pickers and legal suits in this regard shall be dealt by agencies at their own cost. 14.
- Arrangement of drinking water, toilets, bathrooms etc to be used by waste pickers / rag pickers shall be made by empanelled agencies. 15.
- Any other requirements of waste pickers / rag pickers for segregation of waste shall 16.
- If any legal issues are created in regards to segregation of waste by waste pickers / rag pickers, the same shall be dealt by agencies at their own cost. 17.
- The agencies shall be required to adopt adequate safety measures to protect the waste pickers / rag pickers from any incidence of fire at SLF sites. 18.
- The agencies shall follow MSW Rules 2016, Orders of the Hon'ble Courts, Guidelines of Ministry of Environment, CPCB, DPCC or any other Govt. authorities issued in this
