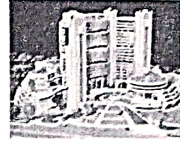


**PUBLIC NOTICE**

**Inviting "Expression of Interest" regarding use to Cow Dung Cakes (Uplas) in Cremation Grounds under jurisdiction of MCD.**

The Competent Authority i.e. Commissioner vide orders dated 01.01.2026 has approved use of Cow Dung Cakes/Uplas/Go-cast to the extent of 75% (preferably 100%) on Pilot basis for Human Cremations for period of 2 years in Green Park Cremation Ground (South Zone), Dwarka Sec-24 Cremation Ground (Wood) (Najafgarh Zone) and Jwala Nagar Cremation Grounds (Shahdra North Zone) under jurisdiction of MCD.

New NGOs/Self Help Groups/RWAs as well as NGOs who had applied earlier for allotment of these Cremation Grounds in response to the "Expression of Interest (EOI)" are hereby requested to submit an undertaking accepting the new terms & conditions in respect of two cremation grounds i.e. Green Park & Dwarka Sec-24 to use 75% (preferably 100%) Upla/Cow dung cakes/Go cast sourced only from Gaushalas/ dairy owners or any producer(s) in Delhi using the cow dung from Gaushala/Diaries located in Delhi on Pilot basis for Human Cremation for period of 2 years. Interested NGOs to submit the documenting proof in this regard. Further rest of conditions of earlier "Expression of Interest (EOI)" remains the same.


