CIRCULAR

Subject:- Final unified seniority list of Family Welfare Worker (FWW) of Municipal Corporation of Delhi with effect from 22.05.2022 onwards – Reg.

In pursuance of provisions of the Delhi Municipal Corporation (Amendment) Act, 2022, notified vide Gazette Notification No. CG-DL-E-18042022-235183 dated 18.04.2022 and in exercise of the powers conferred by Sub-section (1) of Section 3 of the DMC (Amendment) Act, 2022, the Central Government has appointed the 22nd day of May, 2022 for constitution of the Municipal Corporation of Delhi of notified vide No.CG-DL-E-18052022-235827 dated 18.05.2022.

- 2. Further, as per Section 90A (1) of the DMC Act, on the date of establishment of Corporation under sub-section (1) of section 3, the officers and employees of the erstwhile North Delhi Municipal Corporation, South Delhi Municipal Corporation and East Delhi Municipal Corporation shall, with immediate effect, become the officers and employees of the Corporation.
- 3. Accordingly, a provisional seniority list of Family Welfare Worker (FWW) working in Hospital Administration Department, unified MCD was issued by undersigned vide Letter No.:AO(HA)/MCD /HQ/2022 /267 dated 26.08.2022 for obtaining suggestions / comments / objections to the undersigned within 21 days from the date of issue of above mentioned said letter of provisional seniority list for the post of Family Welfare Worker (FWW).
- 4. Some objections were received from incumbents through Concerned Medical Officer Incharge of Health Unit which were removed thereafter Final Seniority List of Family Welfare Worker (regular basis) working in Hospital Administration Department, of unified Municipal Corporation of Delhi from 01.04.1984 onwards, which was issued vide No.:AO(HA)/MCD/HQ/2022/408 dated 11.10.2022. But, Hospital Admin.-HQ have received more some objections after issuing Final Seniority List of FWW which have also been removed herewith and final seniority list of Family Welfare Worker (regular basis) working in Hospital Administration Department, of unified Municipal Corporation of Delhi from 01.04.1984 onwards is hereby once again issued.
