**CIRCULAR**

**Sub:- Final Unified Seniority list of Section Officer of Municipal Corporation of Delhi with effect from 22.05.2022 and onwards.**

In pursuance of provisions of the Delhi Municipal Corporation (Amendment) Act, 2022, notified vide Gazette Notification No. CG-DL-E-18042022-235183 dated 18.04.2022 and in exercise of the powers conferred by Sub-section (1) of Section 3 of the DMC (Amendment) Act, 2022, the Central Government has appointed the 22nd day of May, 2022 for constitution of the Municipal Corporation of Delhi notified vide No. CG-DL-E-18052022-235827 dated 18.05.2022.

2. Further, as per Section 90A(1) of the DMC Act, on the date of establishment of Corporation under sub-section (1) of section 3, the officers and employees of the erstwhile North Delhi Municipal Corporation, South Delhi Municipal Corporation and East Delhi Municipal Corporation shall, with immediate effect, become the officers and employees of the Corporation.
3. Accordingly, a Unified Provisional seniority list of Section Officer of Municipal Corporation of Delhi, as per the available record, on the basis of officers working on 22.05.2022 and onwards is issued for obtaining suggestions/comments/objections vide Circular No. SO-II/AO/CED/MCD/2022/788 dated 18.07.2022.
4. Having considered the objections received against the above-said provisional Seniority list dated 18.07.2022., the Seniority List of Section Officer of Municipal Corporation of Delhi w.e.f. 22.05.2022 has been finalized and circulated herewith for information of all concerned.
5. The above-said seniority is subject to outcome of Court Case, if any, pending in the Court of Law.
