ORDER

In continuation of Order No. Addl. Commissioner (PH)/MCD/2026/D-21/MHO, dated 29.05.2026 regarding deregulation of Health Trade Licence under Sections 417, 420, 421 and 422 of the Delhi Municipal Corporation Act, 1957 after the approval of the Competent Authority in the matter, the categorisation of Health Trades regulated by the Municipal Corporation of Delhi has been reviewed.

Whereas, certain categories of Health Trades continue to involve substantial public health, sanitation, hygiene, lodging, recreational, environmental health and public safety considerations requiring specialised regulatory oversight by the Public Health Department;

Whereas, such establishments, by the very nature of their operations, have direct impact on public health and, therefore, require periodic inspection, monitoring, compliance verification and enforcement by trained public health functionaries to ensure compliance with prescribed public health and sanitation standards;

Whereas, the Competent Authority has approved continuation of Municipal regulation of such trades under the Health Trade Licensing framework so as to ensure effective public health surveillance, maintenance of hygiene standards and protection of public health;

Now, therefore, the trades specified in attached list shall continue to remain under the administrative control of the Public Health Department of MCD.

Accordingly, the following directions are issued:

1. Health Trade Licences in respect of all trades in attached list shall continue to be issued, renewed and regulated by the Public Health Department under relevant Sections of Delhi Municipal Corporation Act, 1957 and instructions issued from time to time.
2. The existing Health Trade Licensing framework, including licensing, inspection, monitoring, compliance verification and enforcement under the provisions of the DMC Act, 1957, shall continue to remain applicable to these trades.

This Order shall come into force with immediate effect.
