## **Terms and conditions**

- 1. Tenure: Initially for a period of 89 days or till the posts are filled up on regular basis whichever is
- Pay & Allowance: As per recommendation of 7th CPC.
- House Rent Allowance: Hostel accommodation is optional and subject to availability of rooms. He/ She will be required to deposit Hostel Security of Rs. 2000/- before he/ she is allotted the Hostel accommodation. The same is refundable. The entitlement for HRA will be as per Govt. Rules.
- 4. General Candidate who selected against the vacant post of SC/ST/OBC/EWS, their tenure will be terminated/discontinue with immediate effect whenever concerned category candidate selected.
- 5. Private Practice: The Private practice of any kind whatsoever is strictly prohibited. Besides the candidates will not work simultaneously as SR in any other Hospital/ Charitable Organization. Breach of this condition will result in termination of appointment/disciplinary action as per rule.
- 6. Leave Entitlement: Only 2 days leave is admissible for each month of service. In case of unauthorized/willful absence of duties for more than 06 days, the appointment shall stand terminated without assigning any reason.
