Sealed "Expression of Interest" are hereby invited by the Medical Superintendent, HRH for exchange of Surplus Plasma by RBTC as per terms & conditions mentioned below. The filled applications along with all the required document must reach in the office of the undersigned on or before 15 Apr 2025 04:00 PM. The Envelope containing the application would please be sealed and super scribed as under:-

"EXPRESSION OF INTEREST FOR EXCHANGE OF SURPLUS NON REACTIVE PLASMA, RBTC, HRH"

RBTC, HRH aims to provide surplus plasma to Indian plasma fractionators as per initiative approved by National Blood Transfusion Council.

Eligibility Criteria:

- The plasma fractionator must be licensed by the Government of India for plasma fractionation for manufacturing clinically usable products in a GMP facility.
- The fractionator will remain accountable to update RBTC, HRH about the nature and quality of all the products manufactured from the plasma received from the institute.
- The fractionator must ensure that none of the products recovered from this plasma will be exported before fulfilling domestic demand.
- The firm should not be black listed by any Govt. Agency/Dept.

Terms & Conditions:

- The firm shall be responsible for the pickup of plasma from the blood center, package
 and transport to their facility and the firm shall maintain proper logistics like
 thermostatic vehicle, weighing machine, shippers and bubble wrapped sheets/bags etc.
 All expenses thus incurred shall be borne by the firm.
- 2. The blood centre shall test the blood, for HIV 1 & 2, Hepatitis C virus antibody, Hepatitis B surface antigen, from which FFP will be made. And shall only handover the units to the firm which are free from these markers.
- The firm shall retest the plasma for freedom from HIV 1 & 2, Hepatitis C virus antibody, Hepatitis B surface antibody.
- The blood centre shall maintain necessary licenses at its own cost. The blood centre shall provide copies of licenses/approval to the firm whenever required.
- The firm shall provide copies of its licenses/approval to the blood centre whenever required.

- The volume of plasma will be calculated as (weight of filled plasma bag-weight of empty bag)/ 1.03.
- 7. Weight of empty bag will be considered as 30 grams.
- 8. The blood centre shall supply only the surplus FFP in a frozen state.
- The exchange value shall be INR Rs 1600 per litre of FFP as per order no: S-12016/01/2012-NACO(NBTC) dated 28/10/2015 and F.No. IM 11012/07/2022/NBTC dated 14th Jun 2022
- 10. The exchange value will be automatically modified as per subsequent government order if any.
- 11. The firm and the blood centre shall maintain confidentiality of all information.
- 12. The blood centre shall keep the blood donors records for at least 5 years.
- 13. The blood centre and the firm shall enter into an agreement which will be valid for 1 year from the signing by the parties (representative of the firm and Medical Superintendent of the Hospital).
- 14. The blood centre will not be bound to exclusively supply the plasma to the firm during the term of the agreement. Similarly the firm is not bound to exclusively procure the plasma from the blood centre.
- 15. RBTC HRH reserves the right to increase or decrease quantity and / or amount of work.
 Decision of Quantity of material in the RBTC HRH will be final in this regard.
- 16. The frequency of handing over surplus plasma to the firm is as per requirements of the blood center
- 17. The blood centre will not be liable for the damages or any other loss due to use of any product made by the firm from the plasma supplied by the blood centre.
- 18. The exchange value earned by the blood centre from the supply of plasma to the firm, will be used against the payment by the firm, for
- The procurement of any equipment or any consumables from any supplier, by the Department of Pathology and Blood bank.
- For buy back of plasma derived products for clinical use by the hospital.
- For strengthening of blood banks capacity.
- For any other use as specified by orders from NBTC, Ministry of Health and Family Welfare, Govt of India, following the provisions of GFR..
- 19. The financial records of the exchange value earned and redeemed shall be kept by the blood center as well as the firm.

- 20. Both the blood centre and the firm shall comply to all the orders and regulations from the government including Drugs & Cosmetics Act/Rules 1940 (including subsequent amendments).
- 21. Both the blood center and the firm shall adhere to Good Manufacturing Practices (GMP) and other ICMR guidelines.
- 22 If the supplier fails to lift the material within stipulated delivery period then the surplus plasma will automatically be handed over to other qualifying firm(s).
- 23. In the event of any dispute or disagreement arising between the Supplier and RBTC, HRH with regards to the interpretation of "Terms & Conditions" of this inquiry, the same shall be referred to the MS, HRH, Delhi whose decision will be final and binding upon the contractor.
- 24.RBTC HRH reserves the right to reject any application from interested party without assigning any reason. Decision of the MS, HRH will be final in this regard.
- 25.More than one firm may qualify subject to fulfillment of eligibility criteria and compliance with NBTC order number F.No. IM 11012/07/2022/NBTC dated 14th Jun 2022. If more than one firm qualifies then the surplus plasma will be handed over to firms alternatively at equally spaced intervals.
