The tender fee and EMD will be payable to **Commissioner SDMC** through online mode only before submission of closing of bid up to 02.03.2022 at 14:00 PM for an amount mentioned each item in table separately. The firms/ agencies blacklisted/ debarred from any Govt. / Semi Govt. organizations shall not be eligible for submission of bids.
2. Technical Bid opening will be held on 03.03.2022 at 14:00 PM in the office of **EE (E&M)-I , ROOM NO. 02 , GATE NO. 09 AMBEDKAR STADIUM , DELHI GATE, DELHI -110002.**
3. Tender forms and specifications can be downloaded from the website <https://eprocure.gov.in> only by the registered/ approved contractor/ manufacturers/ authorized dealers or reputed firms dealing in such specialized jobs. The interested agencies/ firms which are not registered in online tendering with SDMC shall have to register first and then only can participated in the bids the procedure for registration can be seen at <https://eprocure.gov.in>.
4. The bidder should have successfully completed similar works during the last seven years ending last date of month previous to the one in which tenders are invited as mentioned below: -

Three similar works each costing not less than Rs. 20,12,700/-

or

Two similar works each costing not less than Rs. 30,19,050/-,

or

One similar work costing not less than Rs. 40,25,400/-.

Similar works shall mean "Supply Installation Testing & Commissioning of pumping station and its allied works".

5. The average annual financial turnover for the 2018-19, 2019-20 & 2020-21 shall be at least Rs. 25,15,872/-. In case the financial for the financial year 2020-21 is not audited, its un-audited report duly certified by chartered accountant shall submitted along with an undertaking mentioning that the financial for the financial year 2020-21 has not audited till the last date of submission of the bids. Copies of audited balance sheet of the above mentioned financial years, duly certified by a Chartered Accountant shall be submitted in support of the requisite financial turnover.
6. The bidders have to upload valid Net worth of Rs. 5,03,174/-, certificate from certified chartered accountants (Form B).

OR

The bidders have to upload valid solvency of Rs. 20,12,700/- (Form A) , The above certificates can be in any form, but should contain all the relevant information as stipulated in the respective forms.

7. The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during the last five years ending 31st March 2021.
8. Bidders will submit an undertaking that he is not blacklisted/ debarred from any Central/ State Government Department/ Central Autonomous Body/ State Autonomous Body/ Central Public Sector Undertaking/ State Public Sector Undertaking/ City Development Authority/ Municipal Corporation of City formed under any Act by Central/ State Government organization.
9. The bidder has to submit the affidavit. "I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in SDMC in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Performance Guarantee."
Note:- Back to back basis means the works being awarded on an ad-hoc and arbitrary manner without inviting tenders and ascertaining the performance, capability and experience of the tenderer.
10. The sub contractor's work will be considered as eligible similar work and the benefit of the percentage of work so awarded shall be considered for evaluation. In such case bidder's satisfactory completion certificate shall be duly endorsed by the client i.e. parent / original work issuing authority.
11. For Non-Government work in eligible similar work, a certificate regarding financial transactions issued by certified Chartered Accountant must be uploaded by the bidder.
12. The bidder can be submitted the completion certificate as the Performa attached as Form 'C' (min. up to Satisfactory/good), Solvency, Net Worth in any format, however all relevant information desire by the department in respective Performa attached as Form 'A', Form 'B' & Form 'C'. Shall be covered/mentioned in the document submitted by the bidder in the technical document. The Performa attached with Terms & Conditions.
13. Documents to be submitted in the technical bid are as under: -
 - i. Documents in respect of (a) GST (b) Income Tax.
 - ii. The certificate stating that "*GST and Income Tax is regularly and timely being paid to the concerned authorities*".
 - iii. The certificates of satisfactory performance in respect of the executed works duly signed by the concerned Executive Engineer or equivalent along with copy of work orders.
 - iv. Certificate from the bidder that "The offer is as per NIT specifications/ terms & conditions and there is no deviation".
 - v. Letter of authorization for instant bid for further agreement, communication etc.
 - vi. ESIC and EPFO registration documents.
14. The financial bids of only those tenders will be opened whose technical bid are approved by the competent authority in due course.

15. The Lowest firms will enter into the contract agreement through its proprietor or authorized Nominee with Department on prescribed Performa on a non-judicial stamp paper of Rs. 100/-.
16. The department as its sole discretion and without assigning any reason thereof reserves the rights to accept/ reject any/ all bids. The department does not bind itself to accept the lowest bid.
17. Deduction of GST/ Tax at source shall be made as per rules.
18. The rates should be quoted by the tenderers separately for each item including all taxes, if the rates are not quoted for any item it will be treated as zero.
