As per circular no. AO/Engg.(HQ)/SDMC/G-IV/D-1251/ dated 30.12.2021 and AO/Engg.(HQ)/SDMC/G-IV/D-1385 dated 19.01.2022, the enlisted contractor of the MCD/erstwhile South DMC/North DMC/East DMC as well as all contractors already registered with CPWD, State PWDs and Urban Local Bodies having **valid registration**, GST certificate, bank details PAN will be allowed to tender for the amount as per category of contractors given in enlistment rules of SDMC, subject to the conditions that they are neither blacklisted nor debarred at the time of purchase of tenders. However, the outside registered contractors will be allowed to participate as per the category fixed under enlistment rules of MCD.

Tender will be received as per time table and will be opened at 15:05 PM on 04.11.2022 on website https://etenders.gov.in/eprocure/app in the office of EE (SLF) Okhla, Gate No. 04, Room No. 06, Dr. Ambedkar Stadium, New Delhi – 110002. Validity of rates will be 5 months from the date of opening of NIT & in case of negotiation from the date of negotiation. If holiday is declared on the date of opening of tenders, the same will be opened on the next working day.

Conditions given in the printed NIT form A-32, chapter 9 of the Municipal accounts code part I will hold good. The contractors will have to give a declaration about the name of their relatives employed in MCD along with each tender.

For the payment of Tender cost and Earnest money the same has to be deposited online before the closing of online bid and latest circulars/office orders are to be followed along with general conditions of contract for erstwhile South Delhi Municipal Corporation works and shall be part of agreement. Any conditional tender is liable to be rejected. Department reserves rights to reject any tender without assigning any reason.

- The weighing of the C&D material after loading in the trucks shall be done at the weigh bridge at Okhla landfill. The contractor shall be required to submit the weighment slips of the weigh bridge along with his bills and no payment shall be made without the same.
- ii) The contractor shall load/transport the type of material i.e. C&D material as per the directions of Engineer-in-Charge.
- iii) All contractors already registered with MCD/erstwhile SDMC, North DMC, EDMC and also outside contractors from CPWD, State PWDs and Urban Local bodies having valid registration, GST certificate, bank details, PAN, plant capacity and their authorized signatory document will also be uploaded on e-procurement website. For authorized signatory should have valid power of attorney in favour of authorized signatory executed by the competent person of firm or resolution etc. must be uploaded on website.
- Third party quality assurance /audit of the work will be carried out by the selected outside agencies/organizations as per circular vide no 1571 dated 25.10.06, 2816 dated 20.02.07, 2817 dated 20.02.07, 6827 dated 22.12.08 and 10174 dated 23.02.09 except that charges of IIIrd Party Quality Assurance which are already included in C.P & O.H @15% above on DSR 2007 and decision of the Third Party will be applicable to the contractor.
- v) If the rate quoted by the lowest tenderer is found abnormally low the payment to the contractor for the work shall only be made after inspection by the Quality control cell at different stages

and these findings shall be final and binding on the contractor. All the testing charges from the independent laboratory shall be borne by the contractor. in case the lowest contractor fails to commence/complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per the provision of the enlistment rule/instruction issued from time to time.
