MINUTES OF PRE-BID MEETING

12.01.2024

Pre-Bid Meeting was held on 12.01.2024 (Friday) at 10.30 A.M. in conference hall DHA office E1– Block, 18th Floor, Dr SPM Civic Centre, J L N Marg, New Delhi – 110002 by board members with the interested/prospective firms for finalizing outsourcing Laboratory services through provision of collection centres under PPP mode under the chairmanship of Director Hospital Administration, MCD.

The Board members and firms attended the pre-bid meeting as per attendance. Discussion about the terms & conditions of RFP between board members and the representatives of interested firms took place.

The queries/clarifications sent within stipulated time by the three firms on email to the O/o CMO (Project) were taken up one by one in the pre-bid meeting.

Details of the queries/clarifications of the firms is as under:
