Some queries were raised in pre-bid meeting which were explained / replied to the probable bidders as under:

1.	Earnest Money Deposit be exempted for MSME Registered firms.	The proposal will be put up before the competent authority. If approved the same will be notified and updated on MCD website accordingly.
2.	Joint Venture/ Consortium has been allowed in the Tender of Art firm with catalogued exhibitions / events with some other firms (for financing purposes). Allow any company of Joint Venture as Lead Partner instead of only Art Firm as Lead Partner/Member of Joint Venture.	Being a specialized Artistic work the lead member should be an Art Firm only.
3.	Performance Security / guarantee of 5% be reduced to 3% of the tender.	As per terms and conditions of the tender the successful H-1 bidder will have to deposit Rs.1,35.70,753/- as Performance Security with MCD.

5.	Whether Technical Bid & Financial Bids can be submitted manually or not?	As per Tender Document the Technical Bids submission has been allowed online as well as manual. 6.	What items are minimum required to be executed of Electrical Equipments / Fittings not mentioned in the tender document.	The Items to be executed of Electrical Equipments / Fittings & other components are to be notified with necessary Corrigendum and will be uploaded on website accordingly.
7.	Assessing the scrap items available under MCD for execution of sculpture work is time consuming so Date may be extended for Tender submission.	If date of tender submission are extended the same will be notified and updated on MCD website.
8.	At page 3 of tender Document in Table of Contents it has been mentioned that concession agreement document of this project enclosed will be the part of this tender document / request for proposal (R.F.P.). But no Concession Agreement Document has been uploaded by MCD / Tender Issuing Authority.	It will be updated.
9.	In available Tender Document online the organization has been mentioned as North Delhi Municipal Corporation. Clarify the Payment of Tender Cost & EMD in whose favour be made.	NDMC and North Delhi Municipal Corporation be read as MCD and Municipal corporation of Delhi respectively for all purposes. All Payments should be made in favour of "COMMISSIONER-MCD" payable at New Delhi only.
