## **PUBLIC NOTICE FOR AUCTION OF SEIZED GOODS/ITEMS & ARTICLES**

The unclaimed seized goods/ items & articles during the course of encroachment removal action taken by General Branch, Najafgarh Zone under the provisions of DMC Act 1957, will be auctioned on 17th of July, 2025 at 11.00 A.M. at Rewla Khanpur Store, General Branch. The goods/items & articles to be auctioned, can be inspected on any working day between 9 A.M. to 5 P.M. at Municipal Store, Rewla Khanpur, with the prior permission of Admin. Officer, Najafgarh Zone, the terms & Conditions of the auction will be as under:

- 2. Each bidder shall deposit the earnest money of Rs. 1,90,000/- (Rupees One Lakh Ninety Thousand only), which is almost 10% of minimum auction price/reserve price (which is Rs. 19,00,000/- excluding GST) in the shape of Demand Draft in advance i.e. up to 3.00 P.M. of 15th of July, 2025, in favour of "Commissioner, MCD" which shall be returned / adjusted after the auction is over.
- 3. The minimum auction price/reserve price of the entire goods/items & articles to be auctioned is Rs. 19,00,000/- (Rupees Nineteen Lakhs Only) excluding GST.
- 4. The highest bidder whose bid shall be accepted, shall have to deposit the entire amount (after adjusting earnest money) in the shape of Demand Draft, in favour of "Commissioner, MCD", latest by 03 P.M. on 18" July 2025, In the event of failure to pay said amount, the earnest money deposited by the successful bidder, shall be forfeited and the entire process of instant auction shall automatically be considered as cancelled.
- 5. Each bidder shall have to provide self-attested copies of PAN Card, Aadhar Card, and GST/NAT Regn. Details along with the payment of earnest money, as mentioned in terms & conditions of Point No. 1 above.
- 6. The items will be auctioned on "AS IS WHERE IS BASIS" basis & no after claims whatsoever shall be entertained, in any case.
- 7. The successful bidder shall have to remove the goods/ items & articles within 03 days after auction, failing which MCD shall not be having any responsibility for watch & ward of the goods/ items & articles, to be removed.
- 8. The goods/ items & articles will be dismantled to scrap by the successful Bidder. An affidavit in this regard shall be submitted by the successful bidder, before removing goods from the Municipal Store.
- 9. The Deputy Commissioner, Najafgarh Zone reserves the right to reject any or all the bids without assigning any reason, if deemed necessary or the same is in public interest.
