1 (a) The quotations from the bidders shall be submitted in a sealed envelope in the office of Executive Engineer (SLF) on or before 11.05 2021 upto 02:00 pm in the following format:-

- (b) The quotations/bids shall be opened on 11.05.2021 at 04:00 PM.
  - 2. The agencies/bidders may inspect the site by contacting Sh. Sanjay Hingorani, AE (SLF) contact no. 9717788196 on or before 10.05.2021 between 10:00 am to 2:00 pm on any working day. The bidder should satisfy himself about the quality and quantity of the material before taking part in the bid.
  - 3. The Plastic/MLP/RDF will have to be collected by successful bidder on "AS IS WHERE IS" basis. No claim whatsoever regarding the quality, quantity shall be entertained.
  - 4. The bidder shall make his own arrangements for segregation, collection/lifting and transportation of the material. SDMC will be completely indemnified in terms of any liability (Financial, legal or otherwise) with regard to payment towards collection, lifting & transportation and processing cost of the material.
  - 5. The bidder shall be required to collect and transport atleast 150 MT of the material per month. In case of shortfall, Executive Engineer (SLF) reserves the right to terminate the agreement, however the same may be permitted by EE (SLF) under exceptional circumstances.

- 6. The successful bidder/firm may be allowed by SDMC to install machinery/equipment required for segregation/collection/lifting of Plastic/MLP/RDF at the site. However, this shall be at the discretion of EE (SLF) keeping in view the availability of sufficient space/land at the site. Any expenditure incurred towards machinery/manpower/electricity etc shall be completely borne by the bidder/firm.
- 7. The successful bidder shall make the payment to SDMC in the first week of subsequent month as per the accepted rates/quotation for the quantity of Plastic/MLP/RDF lifted during the month in the form of Demand Draft of the Scheduled Bank in favor of Commissioner SDMC in the office of Executive Engineer (SLF) SDMC.
- 8. The highest bidder shall be required to deposit following security amount before the start of work:-

## Bid amount (in Rs.) X 150

The security amount shall be deposited in the form of Demand Draft of the Scheduled Bank in favor of Commissioner SDMC.

The security amount shall be refunded after the expiry of the contract. However, the same shall be forfeited by SDMC in case of any default by the bidder.

- 9. The Plastic/MLP/RDF shall be lifted and transported by the bidder in batches. The measurement/weighing of the material shall be done at the weigh bridge at SLF, Okhla and shall be treated as final. The bidder shall be required to submit the weighment slips of the weigh bridge.
- 10. The successful bidder shall have to dispose off the waste as per PWM rules, 2016 as amended thereafter and other applicable guidelines. The bidder shall be solely responsible for obtaining all the required environmental clearances/permissions.
- 11. The bidder will be required to submit all the documents required by SDMC as and when demanded i/c processing certificate.
- 12. The materials will be removed from the site in presence of the bidder himself or agent duly authorized by him in writing on his behalf. The bidder shall be responsible for any kind of loss to the Govt. property by him during the removal of the material from the site and recovery of the same will be made from him. The bidder will leave storage place of the material quite clean.
- 13. The bidder will have to pay all applicable taxes, if any.
- 14. The period of contract will be one year from the date of signing of the agreement which may be extended with the mutual consent of SDMC and the highest bidder.
- 15. The contract with the successful bidder may be terminated by EE (SLF) SDMC at any stage after giving one month prior notice.
- 16. The work will be awarded to the highest bidder, however SDMC shall have right to empanel other bidders/agencies which consent to work as per the highest bid/rates.
- 17. The Executive Engineer (SLF), SDMC reserves the right to reject any bid or to cancel the bid at any stage without assigning any reason.
