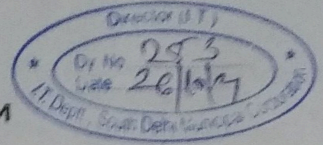

Online Item rate bids are invited for the following works from registered contractors of all Government Departments who are eligible to tender for the amount they have registered in their respective category only, on behalf of Commissioner, SDMC and will be opened as per time table as mentioned above on online e-tender system. In case of holiday the tender will be opened on the next working day, however last date of bid submission will remain same.

Contractors shall abide by the following conditions:

1. Upload the valid registration certificate issued by any Government department, along with EMD exemption Declaration as given below at Sl. No 2 " as mentioned in conditions & Specification in eligibility documents section while online bidding and fill firm name in bidsheet. Both the conditions are mandatory, otherwise bid shall be summarily rejected.
2. For relaxation* of EMD, a bid security declaration is to be submitted by the prospective bidders with each item of the NIT vide circular no. D/ SE (P)/ SDMC/ 2020-21/ 181 Dated: 31.12.2020. The Performa of declaration is as under:
"Whereas I/We (Name of agency) _ have submitted bids for (Name of Work) . I/We hereby submit following declaration in lieu of submitting earnest money deposit.
(1) If after opening of the tender I/We withdraw or modify my/ our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents.

OR

- (2) If after the award of work I/We fail to sign the contract or to submit performance guarantee before the deadline defined in the tender documents. I/We shall be suspended for one year and shall not be eligible to bid for SDMC tenders from the date of issue of suspension order.

3. As per Circular No. D/SE(P)/SDMC/2020-21/181 dated 31/12/2020 there will be no provision of EMD in this NIT upto 31/12/2021(as mentioned at Sl. No2).
4. The tender cost payable to Commissioner, SDMC through online mode only.
5. The lowest tenderer shall enter into the Contract-Agreement through its proprietor or Authorized Nominee with deptt. on prescribed performa on a Non Judicial stamp paper of Rs. 100/-.
6. The department at its sole discretion and without assigning any reason thereof, reserve the rights to accept / reject, any / all, bids. The department does not bind itself to accept the lowest bid.
7. Deduction of GST/ tax at source shall be made as per rules.
8. The rates should be quoted by the tenderers separately for each item with all taxes, if the rates are not quoted for any item it will be treated as zero.
