Consultant / Consultancy Firm / Artist Consultant must have got executed or consulted on a Waste to Art Project similar to this in the last seven years for a Government Institute or PSU or Municipality with submission of Completion / performance certificate for the same from the competent authority, for which the work has been done by the intending consultant. Consultant / Consultancy Firm / Artist should have experience with minimum 2 years of working as professional Consultant / Artist. Consultancy Firm / Artist / Art firm, dealt with catalogued exhibitions / events of Art work / Waste to Art. Consultant / Consultancy Firm / Artist should have experience certificate of working with Waste to Art issued by relevant executing agency. The tenders will be received as per time table and Technical Bids will be opened on 18.08.2022 at 03.30 PM at in the office of undersigned. The bidders shall submit an undertaking that the they have not been blacklisted/ Debarred / Banned /Restrained anywhere in India by any Government department/Government Undertaking. The registered contractors of MCD (SDMC/NDMC/EDMC) are also eligible to tender, subject to technically qualified as per tender document, for the amount they have registered in their respective category subject to the conditions that they are neither black-listed nor debarred/banned / restrained at the time of purchase of tenders. - 4. SELECTION PROCESS A single stage, two-bid system process (Technical & Financial Bid) will be followed for selection of a suitable Artist / Consultant for this work. All interested persons / firms that fulfills eligibility criteria may bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The firm having the lowest financial bid of the tender may be considered for award of work.
- TURNOVER If the bidder is a Business Firm, average Turnover of Rs.4.00 lacs for tast three years will be required.
 Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three financial years, should be submitted. The Registered bidder of MCD and individual artists are exempt from submission of the turnover certificate.
- 6. Tender cost (Non-refundable) and Earnest Money (Refundable) as specified against each tender shall be made by way of Online module during submission of bids. If the bidder is the registered contractor of MCD(SDMC/North DMC/East DMC) it will be exempted from EMD submission on submission of declaration of EMD/Bid Security Declaration as per circular No. D/SE(P) / SDMC / 2020-21/181 dated 31.12.2020.
