The bidder should upload the registration certificate regarding its approval/registration by the MCD/SDMC/Govt. Bidder should not be blacklisted/ debarred from any government body like Corporation, Institute, Council etc. Tender will be received as per time table and will be opened at 11:00 AM on 12.07.2021 on website <https://etenders.gov.in/eprocure/app> in the office of EE (SLF), Gate No. 04, Room No.06, Dr. Ambedkar Stadium, New Delhi - 110002. Validity of rates will be 5 months from the date of opening of NIT & in case of negotiation from the date of negotiation. If holiday is declared on the date of opening of tenders, the same will be opened on the next working day.

Conditions given in the printed NIT form A-32, chapter 9 of the Municipal accounts code part I will hold good. The contractors will have to give a declaration about the name of their relatives employed in MCD along with each tender.

Bidding documents can be downloaded from the website <https://etenders.gov.in/eprocure/app>. Tender cost can be deposited in the form of Bank Draft of a scheduled Bank in favor of Commissioner SDMC.

For the payment of tender cost made through demand draft/ Bank Draft, the contractor has to deposit the same in a sealed envelope before the closing of online bid and the same will be received in the office of **Superintendent Engineer (DEMS)-II HQ, Gate No. 9, Room No. 10, Dr. Ambedkar Stadium, New Delhi-110002** and latest circulars/office orders are to be followed along with general conditions of contract for South Delhi Municipal Corporation works and shall be part of agreement. Any conditional tender is liable to be rejected. Department reserves rights to reject any tender without assigning any reason.

- i) **Short Notice Tenders are invited in open category for empanelment of the agencies for the work from the participated firms. Firms (other than L-1) interested in empanelment has to submit their counter offer at rate quoted by L1. Department will empanel maximum 3 firms and opportunity will be given as per the rates quoted by the bidder from lowest to higher i.e. first opportunity to L2 & second opportunity to L3 and so on. The distribution of the work in percentage among the empanel agency will be as under:-**

- ii) **The weighing of the inert material after loading in the trucks shall be done at the weigh bridge at Okhla landfill. The contractor shall be required to submit the weighment slips of the weigh bridge along with his bills and no payment shall be made without the same.**
- iii) **The contractor shall load/transport the type of material i.e. inert as per the directions of Engineer-in-Charge whose decision shall be final.**
- iv) **Performa for earnest money deposited declaration must be uploaded in each tender vide circular No. D/SE (P)/SDMC/2020-21/181 dated 31-12-2020. In case the bidder fails to submit the Performa for EM deposit declaration, tender will be out rightly rejected.**

- v) All drafts for Tender Cost should have a clear validity of two months at the time of submission of Tenders cost as per commissioner's Circular No.D-086/Com/SDMC/2013 dated 18.2.13.
- vi) Third party quality assurance / audit of the work will be carried out by the selected outside agencies/organizations as per circular vide no 1571 dated 25.10.06, 2816 dated 20.02.07, 2817 dated 20.02.07, 6827 dated 22.12.08 and 10174 dated 23.02.09 except that charges of IIIrd Party Quality Assurance which are already included in C.P & O.H @15% above on DSR 2007 and decision of the Third Party will be applicable to the contractor.
- vii) If the rate quoted by the lowest tenderer is found abnormally low the payment to the contractor for the work shall only be made after inspection by the Quality control cell at different stages and these findings shall be final and binding on the contractor. All the testing charges from the independent laboratory shall be borne by the contractor. In case the lowest contractor fails to commence/complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per the provision of the enlistment rule/instruction issued from time to time.
- viii) The conditions/ guidelines as contained in circulars vide no D/324/EE(P)-III dated 16.06.2004, D/380/EE(P)-III dated 28.3.2005, D/398/EE(P)-III dated 17.06.2005 & D/4/EE/P-III/06 dated 7.03.2006 regarding earnest money and security deposit will be applicable. However in case of consultancy work the conditions contained / mentioned regarding payment in respective item will be applicable.
- ix) Necessary deduction shall be made in the bills towards Delhi VAT Act. as applicable on works and noting extra shall be payable on this account.
