## NOTICE INVITING TENDERS

Municipal Corporation of Delhi (MCD) proposes to set up a Municipal Solid Waste (MSW) Processing Facility adopting WtE technology as per Solid Waste Management Rules, 2016. In this connection, MCD intends to select a suitable developer, in single stage, envelope-procurement system, through transparent tariff based Competitive Bidding process for Setting up of Municipal Solid Waste (MSW) to Energy Facility at Narela-Bawana, Delhi as per Solid Waste Management Rules, 2016 (as amended from time to time) under Public Private Partnership (PPP) mode on Design, Build, Finance, Operate and Transfer (the "DBFOT") basis.
