**Summary and Scope of work:**

RCC and Steel Structural Construction including external finishing works like Aluminum Composite Panel on Facias, Boundary wall, drainage system. Rain Water Harvesting, water proofing at terrace level and internal finishing like Stone flooring, tiles in flooring and dado, aluminum doors & window, Sanitary works, including MEP works like: Electrical works, fire fighting works, Substation works, Ventilation system, fire alarm works. CCTV works. BMS/Car Parking Management System works, Lift works etc.

**Eligibility/Pre Qualifications Criteria:-**

**A. The bidders should have to meet the prequalification criteria as under.**

Bidder should have satisfactorily completed the composite works having component wise minimum value as mentioned below of the total value of the work not less than 80% of 9,93,77,116/- during the last Seven year ending previous day of last date of submission of tenders.

9. **CCTV system Works:- Estimated Cost put to tender:- Rs. 15,43,639/-**  
Three similar works each of value not less than 40% of the estimated cost put to tender for CCTV work.

Two similar works each of value not less than 60% of the estimated cost put to tender for CCTV work.  
OR  
One similar work of value not less than 80% of the estimated cost put to tender for CCTV work.  
Similar work shall mean works of "SITC/Provision of CCTV works".

**The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to last date of receipt of application for tenders.**

- In case the component of the specialized E&M services like: SITC/Provision of fire fighting works, SITC of Substation, SITC of Ventilation system, SITC/Provision of fire alarm works, SITC/Provision of CCTV works, SITC/Provision of BMS/Car Parking Management System works and SITC of lift etc., is not covered in the composite tender but executed under a separate contract the bidder has to submit the relevant experience of satisfactorily completing the respective works in the manner as mentioned from 3 to 9 may also be considered for the purpose of assessing the technical competence only without adding its monetary value for determining the eligibility criteria.
- In case experience is not available with the bidder for Specialized E&M works mentioned above i.e. from 3 to 9, the bidder has to engage the associates who have successfully completed the respective work in the same manner as from 3 to 9 also, the bidder has to submit the agreement with the associates along with its relevant experience of satisfactory completing the works as mentioned from 3 to 9 may also be considered for the purpose of assessing the technical competence only without adding its monetary value for determining the eligibility criteria.

- B. **Average Annual Financial Turnover:** Should have had Average Annual Financial Turnover of Rs.532.00 lakh on construction works during the last three years ending 31st March 2020 (Scanned copy of Certificate from CA to be uploaded).
- C. **Profitability:** Should not have incurred any loss (profit after tax should be positive) in more than two years during the last five years ending 31st March 2020.
- D. **Solvency:** Should have a Solvency of Rs.425.00 lakh (Scanned copy of original solvency to be uploaded)
- E. The bidder has to submit the following documents with tender.  
1. ESI registration 2. EPF registration 3. GST registration 4. PAN Card.
- F. The firms/agencies blacklisted/debarred from any Govt./Semi govt. organization shall not be eligible for submission of bids. A certificate in this regard must be enclosed with technical bid.
- G. **Performance Guarantee:** 5% of tendered and accepted value of the work in the shape of Bank Guarantee issued by a scheduled bank in India in favour of Commissioner, SDMC and the same to be furnished within 15 days of issuance of LOA.

#### **Security Deposit:**

Security Deposit of 5% of tendered cost shall be additional to the Performance Guarantee. At the time of making any payment to the contractor for work done under the contract, a sum at the rate of 10% of the gross amount of each running bill shall be deducted by SDMC till the sum will amount to security deposit of 5% (inclusive of earnest money).

#### **Bid Submission:**

The proposal shall contain technical and financial bids, to be uploaded by the bidder online. The technical bid shall contain Eligibility Documents, Experience Certificate, CA Certificates of Financial Standing, Solvency Certificate, MoUs etc, to be uploaded by the bidder online. After the scrutiny of technical bids, the financial bid of the eligible bidders shall be opened.

Note 1 :- All the Works to be carried out conforming to CPWD Specification amended upto date.

Note 2 :- Bidders not registered in Corporation (SDMC, North DMC and East DMC) will have to get themselves registered in SDMC E-tender portal/Website i.e. [www.https://tenderwizard.com/SOUTHDMCETENDER](https://tenderwizard.com/SOUTHDMCETENDER) for participation. No manual bids would be considered/accepted.
