Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The firm having lowest financial bid shall be considered for award of work.

MANDATORY EXPERIENCE IN SIMILAR WORK Experience of having successfully completed similar works during the last 7 years ending last day of the month previous to the one in which applications are invited. The bidder should have minimum experience of similar nature of works as under:

Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender.
