Departments in their respective categories, in addition to the contractors registered with MCD are eligible to participate in tendering process of MCD by registering themselves on E-Tendering website www.etenders.gov.in subject to the conditions that they are neither black-listed nor debarred at the time of purchase of tender. The enlistment rules applicable to the contractors of Municipal Corporation of Delhi shall be followed *mutatis mutandis* by the registered outside Contractors.

The tender cost and the earnest money should be submitted online Net Banking/Credit/Debit Card or in the form of Challan (NEFT/RTGS) generated from the website. The GST@18% is applicable on the non refundable tenders fee/processing fee.

The conditions as given in the printed NIT form A-32, Chapter-IV, Mpl. Accounts code, Part-I will also hold good. All the applicable taxes will be paid by the contractor. If the rates quoted by the lowest tender are found abnormally low, the payment to the contractor for the work shall only be made after inspection by Quality Control Cell at different stages and the findings shall be final and binding on the contractor. All the testing charges from the independent laboratory shall be borne by contractor. In case the lowest contractors fails to commence/ complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per provisions of the enlistment rule/ instruction issued from time to time.

In all low rated cases below 25% of the justification (formerly known as ALR works), the performance security @ 10% of the amount put to tender shall be deducted/ withheld from the first running bill of the agency. It will be in addition to the security deposited/ deducted as per general conditions of contract. The additional performance security shall be released at the time of final bill on receipt of satisfactory work report from Quality Control/ TPQAA. This performance security shall be in addition to the performance guarantee already being deposited for all works irrespective of their rates.

All latest circulars / orders of Unified MCD are applicable. In addition to already incorporated circulars in the NIT Circular No. CA/DCA/F&G.I/2023/MCD/D-271 dated 18.01.2023, No. GE.QC/MCD/2022-23/D-115 dated 21.02.2023 and D/SE(P)-II/2023-24/08 dated 18.04.2023 shall also be applicable for the subject NIT. Payment after satisfaction completion of work in different Head of Accounts shall be made as per standing instructions from competent authority in this respect till date
