NOTICE INVITING TENDER

1. Open online tenders on Percentage Rates under two-bid system process (Technical & Financial Bid) will be invited on behalf of Commissioner, MCD for selection of suitable contractors on e-tenders website portal <https://etenders.gov.in/eprocure/app> and <https://mcdonline.nic.in>
2. The scope of work includes execution of above said work in MCD Park with defect liability period of minimum, six months after completion of work in Municipal Corporation of Delhi.
3. All interested firms that qualify eligibility criteria may apply. After Receipt of Bids, the Technical bids will be scrutinized by the approved Technical Evaluation Committee and Financial Bids will be opened as per its recommendations.
4. Based on the Technical compliance of each proposal as submitted by the bidder/Applicant, MCD shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The firm having lowest financial bid shall be considered for award of work.
5. The time of completion for execution of work will be 01 (One) or 02 (Two) months and shall be reckoned from 10th day of issue of work order / letter of award.
6. Department will comply all the instruction and directions issued for execution of works under All Development Fund from time to time.
7. Tender cost (Non-refundable) and Earnest Money (Refundable) as specified against each tender shall be made by way of online module during submission of bids.
8. The successful Bidder will have to submit the requisite interest free Performance Security equivalent to 5% (Five percent) in the form of Bank Guarantee/ Demand Draft/ Pay order from a Nationalized/ Scheduled bank in India with branch in New Delhi after issuance of Letter of Intent to the contractor.
9. Period of Validity for acceptance of Tender /R.F.P. rates by bidders for acceptance will be 6 Months.
10. To be eligible for evaluation of its proposal, the applicants have to full fill the following conditions.
12. **RELEVANT EXPERIENCE** :Experience of having successfully completed works during the last 7 years ending previous day of last date of submission of Tender. Three similar completed works costing not less than the amount equal to 40% or more of estimated cost OR Two similar completed works costing not less than the amount equal to 60% of estimated cost or more OR One similar completed work of aggregate cost not less than the amount equal to 80% of estimated cost or more AND one completed work of any nature (either part of above(a) or a separate one) costing not less than the amount equal to 40% of estimated cost with some Central Government Department/ State Government Department/ Central Autonomous Body/ Central Public Sector undertaking/State Public Sector Undertaking/ City Development Authority/Municipal Corporation of City formed under any act by Central/State Government and published in Central/State Gazette.

13. **TURNOVER:** Average annual financial turnover on works should be at least 30% of estimated cost during the immediate last 3 consecutive financial years.
14. **BANKERS' /NETWORTH CERTIFICATE:** Bidders are required to submit Banker's Certificate for an amount equal to 40% or more of estimated cost from a Nationalized / Scheduled bank in India OR the Bidder should have Net-worth Certificate equal to 10% or more of estimated cost, duly certified & issued by Registered C.A.
15. Bidder will submit PAN and GST Registration.
16. Bidder will submit Undertaking that he/she/they has/have not been banned/debarred/black listed / restrained by MCD or any other organization of State/Central Government /undertaking/ Department.
