- In case the order is placed and firm in not in position to execute the supplies, the material will be purchase from the local market and difference will be claimed from the vendor/distributor/supplier.
- Item should be stamped properly i.e. **MCD SUPPLY NOT FOR SALE.**
- The firms are also required to submit the certificate on letter head that rates offered are not higher that the rates quoted in any other Govt. institution of NCT Delhi.
