 Open online item rate tenders are invited from experienced and financially sound eligible Contractors / Firms / Companies for award of Works under single stage two-bid system (Technical & Financial Bid) are invited on behalf of Commissioner, S.D.M.C. Bidding Documents can be downloaded from the website https://etenters.gov.in/eprocure/app OR visit SDMC website www.mcdonline.nic.in/SDMCPortal/ Tenders/CPP-ETENDERS. The Technical bid will be received online as well as manual, However, the financial Bids will be received online only at e- tenders portal of SDMC.

The registered contractors of MCD (SDMC/NSDM/EDMC) are also eligible to tender for the amount they are registered subject
to the condition that they fulfil eligibility requirement in Technical Bid submission. They will upload the valid registration
certificates issued by any Municipal Corporation of Delhi i.e. SDMC/EDMC/NDMC along with "Performa for Earnest Money

4. The Bidder should have sufficient financial turnover Average minimum 100% of Estimated Amount for the respective tender during the last three years. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three financial years, should be submitted. The Registered bidder of SDMC/EDMC/NDMC are exempt from submission of the turnover certificate.

5. SELECTION PROCESS A single stage, two-bid system process (Technical & Financial Bid) will be followed for selection of a suitable contractors for this work. All interested firms that qualify each of the following eligibility criteria may apply. Based on the Technical compliance as submitted by the eligible bidder, SDMC shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The firm having lowest financial bid of respective items shall be considered for award of Rate Contract work to respective L-1 items bidder(s)/firm(s).

6. The Rate Contract will be for a period of one year initially, which can be extended/revised further for one more year on satisfactory performance of the previous contract. SDMC may renew / extend /revise the contract to such further amount / period(s), as it may deem proper, having regard to the quality and manner of the contractor's performance. However, it shall

be with written consent by the contractor in this regard.

7. Tender cost (Non refundable) and EMD / Bid Security as specified against each tender shall be made by online payment at website link. The payments of Tender Cost and Earnest Money should be drawn in favour of Commissioner, SDMC payable at New Delhi and may be submitted online along-with Technical Bids documents. If the bidder is the registered contractor of SDMC/North DMC/East DMC it will be exempted from EMD submission on submission of declaration of EMD/Bid Security Declaration in the technical Bids as per circular No. D/SE(P) / SDMC / 2020-21/181 dated 31.12.2020.

8. PERFORMANCE SECURITY The L-1 firm decided by the department as per evaluation criteria will be considered for award of work. The successful L-1 Bidder will have to submit the requisite interest free Performance Security equivalent to 3% (three percent) of the amount of contract in the form of Bank Draft/Pay Order/ Bank Guarantee/ FDR in favour of commissioner, SDMC payable at New Delhi. The said performance security shall be deposited within 15 days of issue of Letter of Intent/Acceptance from SDMC. Fallure in timely submission of required Performance Security the EMD deposited by contractor shall be forfeited to the SDMC and further necessary action for debarring / blacklisting of bidder may be initiated by S.D.M.C.

Director upto 13:10:2021 upto 3:00 P.M. for timely & proper evaluation of Technical Bid. The Technical Bids shall be opened on the same day at 03:30 P.M. The Technical Bid for qualification for opening of Financial Bid shall comprise (i)Tender Cost in specified form. (ii) Earnest Money in specified form as applicable. (iii)Copy of Valid PAN Registration. (iv)Valid GST Registration. (v) Experience in similar nature of work/s. (vi) Financial Turnover Certificate duly certified by Registered C.A. (vii) The Company/Firm profile Detail of the firm/bidder whether participating as Partnership Firm OR Proprietor-ship Firm OR Individual Firm OR Private Limited Firm or other please specify and submit. (viii) Undertaking that the firm has not been blacklisted/Debarred /Banned anywhere in India by any Government department/Government Undertaking. (ix) Contact No. & E-mail Id of Bidder.

minimum experience of similar nature of works as under:

Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender. OR Two similar completed works costing not less than the amount equal to 60% of the estimated cost put to tender. OR One similar completed work of aggregate cost not less than the amount equal to 80% of estimated cost put to tender. The completion certificate of work(s) executed / completed on account of experience, issued from competent authority must be submitted along-with Technical Bids.

10. Submission of a tender by a bidder implies that he/they has/have read this notice and all other contract relating documents and has/have made himself/themselves aware of the scope and specifications of the work to be done and other factors having a bearing on the execution of the work. CPWD specifications-2009 Volume-I & Volume-II will be followed / considered for execution of work. Conditions given in the printed NIT form A-32, Chapter 9 of the Municipal Accounts Code Part I will hold good. Deduction of Income Tax, VAT, Labour Cess etc. at source shall be made as per rules.

The competent authority on behalf of the SDMC does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed conditions is not fulfilled or any conditional tender submitted by the bidder shall be summarily rejected.
