NOTICE INVITING TENDER

Open Online tenders on Percentage Rates or Item Rates as applicable are invited from experienced and financially sound eligible experienced and financially sound Firms / Agencies / Art Firms which have dealt with Sculptures work(s) under single stage two-bid system (Technical & Financial Bid) are invited on behalf of Commissioner, MCD for selection of a suitable contractor for execution of work under "Waste to Art".

The registered contractors of MCD (erstwhile SDMC/NDMC/EDMC) are also eligible to tender for the amount they are registered subject to the condition that they fulfil eligibility requirement in Technical Bid submission. TURNOVER: The Bidder should have sufficient average financial turnover minimum Rs.97.00 Lacs or more during immediate last three financial years. The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five Financial years. Copy of Financial Turnover Certificate along-with balance sheet, duly certified from a registered CA should be submitted.

SELECTION PROCESS A single stage, two-bid system process (Technical & Financial Bid) will be followed for selection of a suitable contractors for this work. All interested firms that qualify each of the eligibility criteria given in the respective tenders may apply. Based on the Technical compliance of each proposal as submitted by the Applicant, MCD shall shortlist bidders for opening of financial proposal. Financial proposal / Bid of only the firm/s that qualify the said eligibility criteria of respective tenders shall be opened. The firm having overall lowest financial bid shall be considered for award of work.

PERFORMANCE SECURITY The L-1 firm decided by the department as per evaluation criteria will be considered for award of work. The successful L-1 Bidder will have to submit the requisite interest free Performance Security equivalent to 5% (Five percent) of the amount of total contract in the form of Bank Draft/Pay Order/ Bank Guarantee/ FDR in favor of commissioner, MCD payable at New Delhi within 15 days of issue of Letter of Intent/Acceptance from MCD. Failure in timely submission of required Performance Security the EMD deposited by contractor shall be forfeited to the MCD and further necessary action for debarring / blacklisting of bidder may be initiated by MCD.

Tender cost (Non-refundable) and EMD as specified against each tender shall be paid by way of applicable Online module

MANDATORY EXPERIENCE IN SIMILAR WORK Experience of having successfully completed similar works during the last 7 years ending last day of the month previous to the one in which Tender applications are invited. The bidder should have minimum experience of similar nature of works as under: Three similar completed works costing not less than the amount equal to Rs.1.29 Crores OR Two similar completed works costing not less than the amount equal to Rs.1.94 Crores OR One similar completed work of aggregate cost not less than the amount equal to Rs.2.58 Crores AND One completed work of any nature costing not less than the amount equal to Rs.1.29 Crores with some Central Government Department / State Government Department/ Central Autonomous Body / Central Public Sector undertaking in India. The completion certificate along-with copy of work order of work(s) executed / completed on account of experience, issued from competent authority must be submitted along-with Technical Bids. Similar nature of work means "Supply/Installation of Sculptures/Monuments under Waste to Art"

9. Banker Certificate or Networth Certificate: Bidder/ tenderer will have submit fresh/ latest Banking certificate equal to Rs.129.00 Lacs from an Indian Nationalized / Scheduled bank OR bidder may submit

Net- worth Certificate equal to Rs.33.00 Lacs duly verified by a registered CA.

10. BID SUBMISSION: Technical and Financial Bids are to be submitted online. However copy of documents submitted online for technical bids may be made available in the office of Dy. Director (Hort.)/HQ-II before opening date for time for timely evaluation of Technical Bid. No manual submission of bids will be accepted for any reason whatsoever.

14. MCD may disqualify any Applicant/Bidder without notice who submits an incomplete/non-eligible bid. MCD reserves the right, without any obligation or liability, to accept or reject any or all the proposals at any stage of the process, to cancel or modify the process or any part thereof or to vary any of the terms and conditions at any time, without assigning any reason whatsoever.
