**Terms and conditions:-**

1. The quotation should be submitted along with the required documents/certificates.
2. The rates quoted should be valid for a minimum period of twelve months.
3. Any interested firm may visit the department to inspect the equipment and submit the quotations accordingly.
4. The bidder should not be blacklisted or debarred in any govt. institution/department at the time of participation.
5. Preference shall be given to those MCD Empanelled diagnostic centres which are located within an approximate radius of 06 kilometers from the Hindu Rao Hospital, ensuring accessibility, patient convenience and timely reporting.
6. No firm will be eligible to withdraw its rates after the submission of the quotation/tender.
7. Rates shall be strictly as per CGHS approved empanelment rates or additional discount wherever feasible.
8. Rates quoted should not be higher than rates quoted to any other Govt. Hospital/institution.
9. Percentage of applicable taxes must be clearly mentioned. Also it should be clearly mentioned that the quoted rates are inclusive or exclusive of taxes.
10. Centers must possess valid registration, requisite certifications (NABL/NABH, wherever applicable) and statutory compliances.
11. The firm must submit PBG/Security Deposit amounting to Rs. 50000/- (Rupees Fifty Thousand) in the favour of Medical Superintendent, Hindu Rao Hospital to be valid for 14 months from the date of execution of Agreement.
12. The firm shall provide for transportation both ways, for the investigations that requires the presence of indoor patient in the laboratory. All consumables required for the investigation shall be provided by the contractor.
13. Payment will be made on submission of bill after verification from Nodal Officer PMJAY HRH.
14. The Medical Superintendent, HRH reserves the right to reject any or all tenders without assigning any reasons.
15. Firms are requested to submit the following documents in sealed quotations in the name of undersigned clearly mentioning quotation no. and title at Dak Section Room. 117, G Block, Hindu Rao Hospital, Malka Ganj, Delhi -110007:
  - a. Covering letter mentioning the details of contact/authorized person along with the contact number, and the alternate contact person in case of non-availability of first contact person, who can be contacted for the purpose of availing diagnostic facilities.
  - b. An undertaking that the Diagnostics Centre is not blacklisted by MCD on letter head.
  - c. Copy of valid empanelment with MCD.
  - d. Prevailing rate list for various investigations which are approved under CGHS and MCD. Additional discounts for PMJAY Beneficiaries shall be provided wherever feasible.
  - e. Authority letter attesting the signature of authorized person.
  - f. Authorized signatory attested Bank Mandate form for verification of bank account details of Diagnostic/Imaging Centre.
  - g. Declaration of location within a radius of 06 kilometer from Hindu Rao Hospital.
