**Terms and conditions:-**

1. The quotation should be submitted along with the required documents/certificates.
2. The rates quoted should be valid for a minimum period of twelve months.
3. Any interested firm may visit the department to inspect the equipment and submit the quotations accordingly.
4. The bidder should not be blacklisted or debarred in any govt. institution/department at the time of participation.
5. Preference shall be given to Jan Aushadhi Outlets preferably located within a radius of approximately 06 kilometers from the Hindu Rao Hospital, in order to ensure accessibility, timely supply of items and convenience to beneficiaries.
6. No firm will be eligible to withdraw its rates after the submission of the quotation/tender.
7. Rates quoted should not be higher than rates quoted to any other Govt. Hospital/institution.
8. Percentage of applicable taxes must be clearly mentioned. Also it should be clearly mentioned that the quoted rates are inclusive or exclusive of taxes.
9. The L-1 firm must submit PBG/Security Deposit amounting to Rs. 50000/- (Rupees Fifty Thousand Only) in the favour of Medical Superintendent, Hindu Rao Hospital to be valid for 14 months from the date of execution of Agreement.
10. In case of non-delivery of required items within the stipulated time period, the required item will be purchased from the open market and differential increased cost, in any, will be duly deducted from any of his bill pending in Hospital and/or PBG/Security Deposit.
11. Centers must possess valid registration, requisite certifications and statutory compliances.
12. Payment will be made on submission of bill after verification from Nodal Officer PMJAY HRH.
13. Firm must provide rate for medicines, surgical items and other consumables. The lowest quoted rates will be fixed for one year and the concerned firm will provide items for one year at the approved rates.
14. The Medical Superintendent, HRH reserves the right to reject any or all tenders without assigning any reasons.
15. Firms are requested to submit the following documents in sealed quotations in the name of undersigned clearly mentioning quotation no. and title at Dak Section Room. 117, G Block, Hindu Rao Hospital, Malka Ganj, Delhi -110007:
