

**OFFICE ORDER**

In pursuance of the Offer of Appointment issued by DEMS (HQ) vide No. 4297/AC/DEMS/HQ/MCD/2024 dated 05.11.2024 with the prior approval of the Commissioner and consequent upon the acceptance of offer of appointment by the applicant duly received by DEMS/Asstt. Commissioner/Najafgarh Zone/MCD Dairy No. 2123/F dated 07.01.2025, Sh. Saurabh S/o Late Sh. Surender is hereby appointed as regular Safai Karamchari in Level - 1 of 7<sup>th</sup> CPC on usual terms & conditions of RRs of RSK, as a special case on compassionate ground on probation for a period of two years, against the vacant post of deceased employee Late. Sh. Surender subject to the following conditions:-

1. Sh. Saurabh S/o Late Sh. Surender will draw his salary in level 1 of the Pay Matrix under 7<sup>th</sup> CPC.
