OFFICE ORDER

In pursuance of the Offer of Appointment issued by DEMS (HQ) vide No. 452/AO/DEMS/HQ/MCD/2023 dated 24.04.2023 and consequent upon the acceptance of offer of appointment by the applicant duly received by DEMS/KBZ vide no. 3433 dated 28.04.2023, the Commissioner, MCD vide his order dated 24.04.2023 has been pleased to appoint Smt. Rajni W/o late Sh. Rajkumar S/o late Sh. Charan Dass as regular Safai Karamchari in the Level -1 of 7th CPC on usual terms & conditions of RRs of RSK, as a special case on compassionate ground on probation for a period of two years, subject to the following conditions:-

1. Smt. Rajni W/o late Sh. Rajkumar S/o late Sh. Charan Dass will draw her salary in level 1 of the Pay Matrix under 7th CPC.
2. Smt. Rajni W/o late Sh. Rajkumar S/o late Sh. Charan Dass, is being appointed after having been found medically fit by the Medical Board of Hindu Rao Hospital, Delhi.
3. The appointment is being made after the verification of character and antecedents of Smt. Rajni W/o late Sh. Rajkumar S/o late Sh. Charan Dass, from the concerned police authorities.
4. The appointment is subject to the terms and conditions as contained in the offer of appointment made to Smt. Rajni W/o late Sh. Rajkumar S/o late Sh. Charan Dass, vide letter no. 452/AO/DEMS/HQ/MCD/2023 dated 24.04.2023.
5. The appointment will take effect from the actual date of joining of Smt. Rajni W/o late Sh. Rajkumar S/o late Sh. Charan Dass.
6. The remuneration of the employee shall be charged against a vacant post of Regular Safai Karamchari in Karol Bagh Zone.
7. The appointment, being a special case, shall not be treated as precedent in future.
8. The appointment shall be liable to be terminated at any time before expiry of the term specified herein above, at the discretion of the Commissioner, MCD, without any prior notice.
9. Smt. Rajni W/o late Sh. Rajkumar S/o late Sh. Charan Dass, is directed to report to Assistant Commissioner, Karol Bagh Zone, within 15 days of issue of this order positively for further posting, failing which the appointment stand cancelled without further notice.
