OFFICE ORDER

2. The above said ad-hoc promotion shall be subject to following terms and conditions:-

- (i) The appointment shall be purely on ad-hoc basis, as a matter of stop-gap arrangement and shall not be entitled to claim any benefit on account of the said promotion.
- (ii) The ad-hoc promotion will continue till superannuation or one year or till the post are filled on regular basis or till further order, whichever is earlier.
- (iii) The appointment is on ad-hoc basis, pending regular appointment in accordance with the Recruitment Rules and will not confer any privilege of right on the employees for regular appointment to the post.
- (iv) The period of ad-hoc service will not be counted towards eligibility period for regular appointment or determination of seniority.
- (v) The ad-hoc appointment can be terminated at any time without assigning any reason and giving any prior notice as and when required.
- (vi) The above said ad-hoc appointment shall be further subject to the instructions/guidelines issued by the Government of India/Municipal Corporation of Delhi from time to time.
- (vii) The above said ad-hoc appointment is also subject to the condition that as and when any senior official(s) will be available for the post of ASI, if required, the junior most ASI will be reverted to the substantive post.
