**OFFICE ORDER**

In pursuance of the Offer of Appointment issued by DEMS (HQ) vide No. 923/ADC/DEMS/HQ/MCD/2025 dated 13.06.2025 and consequent upon the acceptance of offer of appointment by the applicant, forwarded by DEMS/Central Zone vide dairy No. F/1150/DC dated 07.07.2025 as well as Police Clearance Certificate (PCC), Sh. Shish Pal is hereby appointed as regular Safai Karamchari in Level - 1 of 7<sup>th</sup> CPC on usual terms & conditions of RRs of RSK, as a special case on compassionate ground on probation for a period of two years, against the vacant post of RSK occurred due to Voluntary Retirement on medical grounds of his father Sh. Shish Pal, RSK, Central Zone subject to the following conditions:-

2. Sh. Aniket S/o Sh. Shish Pal is being appointed after having been found medically fit by the Medical Officer 4/C, Lajpat Nagar Colony Hospital, Municipal Corporation of Delhi.
3. The appointment is being made after Police Verification (character and antecedents of Sh. Aniket S/o Sh. Shish Pal) as intimated by the Zonal Authorities of Central Zone.
4. The appointment is subject to the terms and conditions as contained in the offer of appointment made to Sh. Aniket S/o Sh. Shish Pal, vide Office Order no. 923/ADC/DEMS/HQ/MCD/2025 dated 13.06.2025 & Deputy Commissioner/Central Zone/MCD vide No. F/1150/DC dated 07.07.2025 and also subject to the guidelines of GOI.
5. The appointment will take effect from the actual date of joining of Sh. Aniket S/o Sh. Shish Pal.
6. The remuneration of the employee shall be charged against the vacant post arisen due to the Voluntary Retirement from by Service employee Sh. Shish Pal, RSK in Central Zone.
7. The appointment, being a special case, shall not be treated as precedent in future.

Consequent upon appointment, Sh. Aniket S/o Sh. Shish Pal is directed to report to Assistant Commissioner, Central Zone, within 15 days from the date of issuance of this Office Order positively for further posting, failing which the appointment shall stand, cancelled without further notice.
