OFFICE ORDER

In Compliance with the order dated 26.02.2026 in CP No. 1100(2025), CM Appl. No. 684(2026), titled as Ajay Kumar Sharma Vs. Sh. Ashwani Kumar, The Commissioner, MCD, in WP(C) No. 1823(2021) of Hon'ble High Court of Delhi, Sh. Ajay Kumar Sharma S/o Sh. J.P.Sharma, Asstt. Engineer (Civil) on regular basis (going to retire on superannuation on 28.02.2026), is hereby assigned the look after charge to the post of Executive Engineer (Civil), without any additional financial entitlement (as per the order dated 26.02.2026 of Hon'ble High Court Delhi), in his own pay scale of Asstt. Engineer (Civil) without any extra remuneration, on the usual terms and conditions of look after charge, subject to outcome of Court case(s) if any, pending in the court of law:-

2. The abovesaid assignment of look after charge shall be subject to following terms and conditions:-

(a)	The assignment of Look After Charge, is not promotion. It is a stop gap arrangement. Hence the officer mentioned above shall not be entitled to claim any benefit of pay and allowances attached to the post of Executive Engineer (Civil) on account of the said assignment of Look after charge of the post of Executive Engineer (Civil). However, he can exercise full financial/administrative powers attached to the post of Executive Engineer (Civil) during the period of the said Look after charge.
(b)	The assignment of look after charge will be subject to pending regular/ad-hoc promotion in accordance with the Recruitment Regulations and will not confer any privilege or right on the officer for adhoc or regular promotion to the said post.
(c)	The assignment of look after charge shall not be entitled the official for promotion to the post of Executive Engineer (Civil) on adhoc basis or regular basis.
(d)	The period of service rendered on the assignment of look after charge shall not be counted as qualifying service for promotion to the any higher grade post or for seniority, whatsoever.
(e)	The assignment of look after charge may be withdrawn at any time, if the senior official found suitable later on after exoneration in the RDA/Police case(s) pending against the senior official or otherwise.
(f)	The assignment of look after charge shall be withdrawn at any time without assigning any reason or giving any prior notice, as & when required.
(g)	The assignment shall be subject to outcome of Court Case(s)/Stay, if any and in case of any discrepancies noted at a later stage, the grievances will be settled as per rule, if found necessary.
(h)	The abovesaid assignment of look after charge is subject to the submission of Undertaking by the officer before allowing him to commence (joining) his assignment of Look after charge as Executive Engineer (Civil) that "he/she shall not claim any benefit of pay and allowances attached to the post of Executive Engineer (Civil) or for counting of the said period for the purpose of promotion and seniority to any higher posts in future on account of the said assignment of Look after charge of the post of Executive Engineer (Civil)".

3. Consequent upon look after charge to the post of Executive Engineer (Civil), the above said officer is hereby directed to report to Engineer-in-Chief-II for further duties.

4. The aforesaid order is subject to the outcome, if the Corporation challenges the order passed by the Hon'ble High Court dated 26.02.2026, if any.
