**OFFICE ORDER**


Consequent upon approval of Competent Authority, Sh. Braham Prakash Sharma S/o Sh. Kishan Dutt Sharma, Sanitary Inspector, (BMID No. 51803493), working in DEMS/Shah. North Zone is hereby granted ad-hoc promotion to the post of Chief Sanitary Inspector in level 6<sup>th</sup> of pay matrix as per 7<sup>th</sup> CPC, with immediate effect up to 31.07.2025 i.e. the date of his retirement on attaining the age of superannuation.

2. The above said ad-hoc promotion shall be subject to following terms and conditions:-

- (i) The appointment shall be purely on ad-hoc basis, as a matter of stop-gap arrangement and shall not be entitled to claim any benefit on account of the said promotion.
- (ii) The ad-hoc promotion will continue till superannuation i.e. 31.07.2025 or till further order, whichever is earlier.
- (iii) The appointment is on ad-hoc basis, pending regular appointment in accordance with the Recruitment Rules and will not confer any privilege of right on the employees for regular appointment to the post.
- (iv) The period of ad-hoc service will not be counted towards eligibility period for regular appointment or determination of seniority.
- (v) The ad-hoc appointment can be terminated at any time without assigning any reason and giving any prior notice as and when required.
- (vi) The above said ad-hoc appointment shall be further subject to the instructions/guidelines issued by the Government of India/Municipal Corporation of Delhi from time to time.
- (vii) The above said ad-hoc appointment is also subject to the condition that as and when any senior official(s) will be available for the post of CSI, if required, the junior most CSI will be reverted to the substantive post of SI.
- (viii) The ad-hoc appointment shall be further subject to outcome of pending court case(s)/stay, if any.

3. Consequent upon promotion, Official is hereby directed to report to DC/Shah. North Zone for further duties under intimation to DEMS (HQ).
