**OFFICE ORDER**

Consequent upon the recommendations of Zonal Screening Committee, chaired and recommended by the Dy. Cm./Central Zone, coupled with approval of the Addl. Commissioner (DEMS) dated 18.09.2024, Sh. Mari Raj John S/o Sh. Anthony, Leprosy Cured DWSK, (BMID No. 51200781), engaged on daily wages as SK on 16.05.2003, is hereby regularized w.e.f. 01.04.2006 with immediate effect on notional basis, on the parity of his counterparts who have also been regularized w.e.f. 01.04.2006 on notional basis, in the pay scale of Rs. 2550-3200 (pre-revised) revised to level-I in the matrix of 7<sup>th</sup> CPC, on the usual terms and conditions of such regularization and further subject to outcome of Court case(s)/Stay pending in the Court of Law, if any.

Office Order shall be issued separately by the DEMS/HQ after completing all other formalities as mentioned in the Circular No. 330/ADC/DEMS/HQ/2023 dated 03.02.2023 which are as under:-

1. After receiving acceptance of Term and Conditions of individual, the file shall be sent to DEMS/HQ for issuing of regularization Office Order.
2. After issuing of individual Regularization Office Order from DEMS/HQ, Joining of duties will be allowed by Zonal Authorities against the vacant posts, subject to Police Verification Report. In case of any adverse remark(s) in the Police Verification Report, matter shall be brought to the notice of DEMS/HQ for further necessary action as per rule.
3. In case of declaration of age in the affidavit, the Medical Board is requested to determine the age of the official(s). The age declared by the official in different document(s) i.e. Affidavit, Ration Card, Voter-ID-Card etc. be indicated in the medical letter for convenience of Medical Board.
4. There may be variation in Data such as spelling in name, BMID, DOB, DOE etc. from the seniority list. The variation has been due to typo error or otherwise at Zonal level and concerned authority(s) have corrected that data, which has been taken as per recommendations of Zonal Screening Committee headed by the Zonal DC.
