	appointment or determination of seniority.
(v)	The ad-hoc promotion can be terminated at any time without assigning any reason and
	without giving any prior notice as and when required.
(vi)	The ad-hoc promotion shall be further subject to the instructions/guidelines issued by the
	Government of India/Municipal Corporation of Delhi from time to time in this regard.
(vii)	The above said ad-hoc promotion is subject to the condition that as and when the regular
	incumbent(s) will be available for the post of Section Officer, if required, the junior most
	officer(s) will be reverted to the post of Assistant Section Officer post.
(viii)	The above said ad-hoc promotion will be effective from the date of joining of the
-	incumbent.
(ix)	The above said ad-hoc promotion is subject to outcome of Court Case, if any pending in
	the Court of Law.
