OFFICE ORDER

In compliance of judgment dated 11.12.2018 of Hon'ble CAT, Principal Bench in OA No. 2937/2018 titled as Sundeep Kumar Sharma & 05 other Vs North DMC & UPSC and on the recommendations of DPC held in the UPSC on 28.03.2023 for the vacancy year 2004-05 to 2022, as contained in their letter No. F.1/30(4)/2022-AP-1 dated 28.03.2023, the promotion order in respect of 11 Engineers has been issued vide O.O.
