**OFFICE ORDER**

In pursuance of direction dated 22.10.2024 of Competent Authority and consequent upon recommendations of the Review Departmental Screening Committee held on 25.10.2024 to Review the Original DSC dated 16.02.2024 and with the approval of Competent Authority, the following Executive Engineer (Civil) on LAC/Assistant Engineers (Civil) on regular are hereby granted ad-hoc promotion to the post of Executive Engineer (Civil) in level-11 of Pay Matrix as per 7<sup>th</sup> Pay Commission, with effect from 19.02.2024 (notionally) (i.e. date of ad-hoc promotion of their juniors as per DSC dated 16.02.2024) and actually with immediate effect, initially for a period of one year or till the post is filled up on regular basis or till further orders, whichever is earlier, subject to outcome of Court Case OA No. 3338/2024, titled as "Ramesh Kumar Goel Vs MCD" and subject to pending court case(s) and subject to Final Seniority List of Asstt. Engineer (Civil) to be finalised in pursuance of Provisional Seniority List of Asstt. Engineer (Civil) dated 28.08.2024 in the matter:-

2. The above said ad-hoc promotion to the post of Executive Engineer (Civil) shall be subject to the following terms and conditions:-

(i)	The abovesaid promotion shall be purely on ad-hoc basis, as a matter of stop-gap arrangement and shall not entitle the officer to claim any benefit on account of the said promotion.
(ii)	The abovesaid promotion is on ad-hoc basis, pending regular appointment in accordance with the Recruitment Regulations and will not confer any privilege or right on the officer for regular appointment to the said post.
(iii)	The period of ad-hoc service will not be counted towards eligibility period for regular appointment or determination of seniority.
(iv)	The abovesaid promotion can be terminated at any time without assigning any reason and giving any prior notice as and when required.
(v)	The above said promotion shall be further subject to the instructions/guidelines issued by the Government of India/Corporation from time to time in this regard.
(vi)	The ad-hoc promotion shall be further subject to the decision of the Court Case(s), if any.

(vii)	The abovesaid ad-hoc promotion to the post of Executive Engineer (Civil) in respect of abovesaid Engineers shall be subject to the condition that if any senior Asstt. Engineer (Civil) becomes eligible for promotion on ad-hoc basis to the grade of Executive Engineer (Civil), the junior most officer shall be reverted to the substantive post, to accommodate his senior(s).

5. Consequent upon ad-hoc promotion, above said Engineers are hereby directed to report to Engineer-in-Chief-II for further duties as EE(Civil).
