(iv)	The ad-hoc promotion can be terminated at any time without assigning any reason and giving any prior notice as and when required.
(v)	The above said ad-hoc promotion shall be forth
(vi)	The ad-hoc promotion shall be further coshing to the first regard.
(vii)	The ad-hoc promotion shall be further subject to the decision of the Court Case(s)/stay, if any. The ad hoc promotion will be further subject to the condition that as & when any senior officer becomes eligible for promotion on ad-hoc basis, the junior most officer will be reverted back to accommodate his senior(s).
