OFFICE ORDER

No. F.8(8)/CED-III/87/Pt.VI/2008/15/18191 dated 08.09.2008 & minutes of Review DPC was notified vide CED's O.O. No. F.8(8)/CED(NDMC)/Rev.2008/2015/3522 dated 15.10.2015. After granting this effect, his name is treated as withdrawn from Sl. No. 2 mentioned in office-order No. F.8(8)/CED(NDMC)/Pt.VII/2015/GF-02/98 dated 12.01.2017.
