OFFICE ORDER

Consequent upon recommendations of Departmental Screening Committee held on 28.10.2022, subsequent clarification received from the Union Public Service Commission (UPSC) vide No. File No. 1/30(11)/2016-AP.I dated 16.01.2023 & in compliance of the order dated 22.12.2022 of Hon'ble Principal Bench, New Delhi in OA No. 3022/2021, MA No. 3538/2022, MA No. 3187/2022 and with the approval of Competent Authority, Shri Ram Charan S/o Shri Ram Jivan, Executive Engineer (Civil) on regular basis is hereby granted ad-hoc promotion to the post of Superintending Engineer (Civil) w.e.f. 03.11.2022 on notional basis (i.e. the date of issue of office order No. F.7(10)/CED/86/Pt. IX/2022/GF-70/2962 dated 03.11.2022) and actual with immediate effect, in Pay Band-3, Rs. 15600-39100 + Grade Pay Rs.7600/- revised to level-12 of Pay Matrix as per 7th Pay Commission, till the post is filled up on regular basis or till further orders, whichever is earlier, subject to outcome of Court Cases/Stay, if any pending in the court of Law:-

2. The above said ad-hoc appointment to the post of Superintending Engineer (Civil) shall be subject to the following terms and conditions:-

(i)	The appointment shall be purely on ad-hoc basis, as a matter of stop-gap arrangement and shall not entitle the officer to claim any benefit on account of the said promotion.
(ii)	The appointment is on ad-hoc basis, pending regular appointment in accordance with the Recruitment Regulations and will not confer any privilege or right on the officer for regular appointment to the said post.
(iii)	The period of ad-hoc service will not be counted towards eligibility period for regular appointment or determination of seniority.
(iv)	The ad-hoc appointment can be terminated at any time without assigning any reason and giving any prior notice as and when required.
(v)	The above said ad-hoc appointment shall be further subject to the instructions/guidelines issued by the Government of India/Corporation from time to time in this regard.
(vi)	The ad-hoc appointment shall be further subject to the decision of the Court Case(s)/stay, if any.
(vii)	The ad-hoc promotion to the post of SE (Civil) in respect of above said Engineer shall be subject to the condition that consequent upon issuance of order after opening of sealed cover of recommendations of UPSC of the DPC to the post of EE (Civil), as & when any senior EE (Civil) becomes eligible for promotion in the grade of SE (Civil) on adhoc basis, the junior most officer will be reverted to the substantive post, to accommodate his senior(s).

3. Consequent upon ad-hoc promotion, the above said Engineer is hereby directed to report to Engineer-in-Chief-II for further posting/duties as S.E. (C) under intimation to this office.
