OFFICE ORDER

Consequent upon recommendations of Departmental Screening Committee held on 17.02.2023 and with the approval of Competent Authority, under the provisions of DoP&T O.M. No. 22011/4/91-Estt.(A) dated 14.09.1992 and to remove the anomaly in pay, the following Engineers (Civil) are hereby granted ad-hoc promotion to the post of Superintending Engineer (Civil) w.e.f. the date mentioned against each on notional basis i.e. date of their juniors were promoted as Superintending Engineer (Civil) on ad-hoc basis on the usual terms and conditions of ad-hoc promotion, in Pay Level -12 of pay matrix as per 7th CPC):-

The DSC considered the request of Sh. Anil Dalal S/o Sh. Balbir Singh Dalal, Retd. CE (C) on LAC regarding grant of adhoc promotion to the post of SE (C) from the date of promotion of his juniors but keeping in view of the penalty of 'Censure' vide O.O. No. 1/257/2006/Vig./P/2016/1192 dt. 06.12.2016 in RDA No. 1/257/2006 (C/s issued on 29.04.2010) and penalty of 'Censure' vide O.O. No. 1/202/2010/Vig./P/RSB/2019/424 dt. 19.11.2019 in RDA No. 1/202/2010 (charge sheet issued on 06.07.2018) and found no scope of any change for adhoc promotion from the date of his juniors as the adhoc promotion granted to him to the post of SE(Civil) w.e.f. 01.03.2017 vide O.O. No. F.7(10)/CED/86/Pt.VIII/2015/2017/GF-07/526 dated 01.03.2017 is in order.

Further, monetary benefits on the post will be admissible only from the date of actual promotion order already issued in respect of above-said each officers, subject to outcome of Court Cases/Stay, if any pending in the court of Law.
