Order of blacklisting of M/s PRP Enterprises from the panel of Advertisers of MCD.

Whereas, contract for display of advertisement through 13 number of Flag Signs (total area 39 sq. mtr.) within Community Centre, Vikas Puri, West Zone.

Whereas a demand notice was issued vide No.CO(Advtt.)/WZ/SDMC/ 2020-21/D-777 dated 24.01.2022 regarding clearance of dues amounting to Rs.5,62,344/-within seven.

Whereas another Notice of Demand U/s 154 (1) of DMC Act was issued vide No.CO(Advtt.)/WZ/SDMC/2022-23/D-22 dated 03.06.2022 for an amount of Rs.5,98,624/- upto May, 2022 including interest as applicable under Terms & Conditions of NIT/Tender for clearance of dues within 30 days.

Whereas Warrant of Distress under Section 156(i) of DMC Act, was issued to the Branch Manager, The Karur Vysya Bank Limited vide No.CO(Advtt.)/WZ/SDMC/2023-24/D-413 dated 22.05.2023 for recovery of amount of Rs.7;71,201/-. The bank vide letter No.GEN/KUB/01/2023-24 dated 24.05.2023 has informed that the account of the firm has negative balance.

The aforesaid facts and gestures of M/s PRP Enterprises are considered malpractice, against the fair business practices and as breach of trust. Hence this department is constrained to blacklist M/s PRP Enterprises from the panel of Advertisers in MCD for five years from the date of issue of this Order.

The above action of blacklisting is in addition to the necessary steps/action being taken simultaneously by this department against you, for recovery of dues etc. You are further advised to deposit the balance amount at the earliest.
