Some queries were raised in pre-bid meeting, which were explained / replied to the satisfaction of probable bidders and are given as under:

1.	MSME certified/registered company be allowed EMD exemption for participating in the tender	There is no exemption from submission of EMD for any bidder.
2.	How the JV partners are supposed to participate in the online bidding? Whether any of the company in the JVC or the lead company can represent?	Joint Venture / Consortium of Art firm(s) with some other firms/companies are also eligible to participate in the tender as per tender document T & C. The JV firms must submit in the technical Bids the identity of the firms submitting the online tenders on behalf of JV participants. For further clarification may refer the Section 3.6 of Tender Document.
3.	Whether Technical Bid & Financial Bids can be submitted manually or not?	The Technical Bids and Financial Bids must be submitted online only.
4.	How many maximum bidders will be issued Parallel Rate Contract?	Rate Contract will be issued for Rs.200.00 Lacs to successful L-1 Bidder and Rs.200.00 lacs each Parallel Rate Contract Amount will be issued to other bidder matching the L-1 Rates as per Section 13.2 of Tender Document.
5.	Bank Solvency Certificate be exempted for participation in this tender of Waste to Art.	As per Terms and Conditions of the tender there is no exemption from submission of Solvency Certificate. Upload copy of solvency certificate in technical Bids. It is mandatory for bidders to submit Bank Solvency Certificate for this tender in original for an equal / more amount of Rs.120.00 Lacs from a Nationalised/Scheduled bank in India in the office of Dy. Director (Hort.) HQ-II at 16 th Floor E-1 Block S.P.M. Civic centre New Delhi-110002.
6.	Should the Art firm have documented proof of working with waste to art and should have executed the same for any government organization or municipal body of India.	Art firm/Artists associated with the bidding Art Firm should have documented proof of working with Waste to Art and should have executed the same for any Government Organization or Municipal body of India for getting the work done of Artistic Sculptures.
