Clarifications to the queries raised during pre-bid meeting by the prospective bidders on the EoI documents regarding Supply of hot Cooked Food to the children studying in Shah. North, Shah. South & Najafgarh Zone.

Dear Prospective Bidder,

It is to inform that a pre-bid meeting was held on 17.01.2023 at Conference Hall at Education Department, 15th Floor, Civic Center, JLN Marg, New Delhi in respect of inviting of two EoIs for providing hot cooked food to the children studying in Municipal and Aided Schools of MCD of Shah. North, Shah. North Zone and Najafgarh Zone. During the pre-bid meeting, some representatives of NGOs have raised some queries. The point wise reply to these queries is as follows:

	Some representative of NGOs requested to criteria for awarding the marks to the NGO on the basis of Kitchen Plotted area may be modified and award 2 marks to all bidder having 1000 sq. yard plotted area.		
2.	Some representatives of NGOs have stated that "No Objection Certificate" may be not received from Fire Department during short period hence the clause may be modified.		The clause remains unchanged. It is submitted that as per terms and conditions of the EoI Fire safety Measure should be installed in Kitchen Premises. The clause of the EoI is as under: "Adequate fire extinguishers/fire safety measures must be installed and made
3.	Some representatives of NGOs have stated that "No Objection Certificate" from Health Department of MCD should be not required for running the Kitchen hence the clause may be modified.		It is submitted that as per terms and conditions of the EoI "The Organization must have all required certifications such as MCD health license/ certificate, Water Test Certificate etc." A license from Health Department of MCD is required for cooking & serving of food, hence the clause remains unchanged.
4.	providing cooked food to ICDS centers.		It is submitted that experience will be considered of all NGO who are providing hot cooked food to children in Govt. organizations.

The prospective NGOs are advised to take into account the above mentioned clarifications at the time of submitting of their proposal on CPP Portal.
