

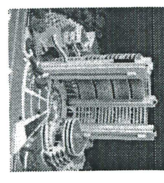

CIRCULAR

Subject:- Provisional unified seniority list of Refractionist who are working in Municipal Corporation of Delhi with effect from 22.05.2022 onwards – Reg.

In pursuance of provisions of the Delhi Municipal Corporation (Amendment) Act, 2022, notified vide Gazette Notification No. CG-DL-E-18042022-235183 dated 18.04.2022 and in exercise of the powers conferred by Sub-section (1) of Section 3 of the DMC (Amendment) Act, 2022, the Central Government has appointed the 22nd day of May, 2022 for constitution of the Municipal Corporation of Delhi of notified vide No.CG-DL-E-18052022-235827 dated 18.05.2022.

2. Further, as per Section 90A (1) of the DMC Act, on the date of establishment of Corporation under sub-section (1) of section 3, the officers and employees of the erstwhile North Delhi Municipal Corporation, South Delhi Municipal Corporation and East Delhi Municipal Corporation shall, with immediate effect, become the officers and employees of the Corporation.

3. Accordingly, a **provisional seniority list of Refractionist** who are working in Hospital Administration Department of unified Municipal Corporation of Delhi, as per available record, on the basis of officials working **on 22.05.2022** onwards is issued for obtaining suggestions / comments / objections to the undersigned within **21 days** from the date of issue of this Circular.

4. Concerned DDOs are requested to ensure wide publicity and also to bring this into the notice of all the incumbents working under their control. Concerned DDOs are also directed to check and verify the particulars of **Refractionist** working under them & send any discrepancies to undersigned. This may be treated as **"Most Urgent"** and be taken on priority basis for preparation of Final Seniority List.
