The bidder shall indemnify SDMC in case of any penalty imposed by any statutory authority for any violation of the rules and regulations.
- 12. The bidder shall be solely responsible for obtaining all the required environmental clearances/permissions before utilization of the auctioned material.
- 13. The bidder shall be responsible for any kind of loss to the Govt. property by him during the removal of the auctioned articles from the site and recovery of the same will be made from him.
- 14. The required T&P and the ways & means of taking out/dismantling of the auctioned material and their final removal from the site shall be responsibility of the successful bidder. No request for extra cost and/or T&P shall be entertained by the department.
