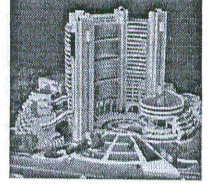





- i. The engagement is purely on contract basis for an initial period of one year or till the time the posts are filled up on regular basis by CED through UPSC, whichever is earlier. The contractual agreement can at any time be terminated by any of the Party (MCD is 1st Party & selected candidate is 2nd Party) by giving ONE (01) Month Notice in advance or by the 2nd Party by depositing 01 Months Contractual Remuneration.
- ii. The Appointing Authority reserves right to assign any duty as and when required. No extra allowance will be admissible in case of such assignment.
- iii. The engagement shall not be entitled to any other benefit such as Provident Fund, Pension, Gratuity, Medical Attendance treatment, Seniority etc. which are available to the MCD employees appointed on regular basis.
